FULL TEXT OF PROPOSED AMENDMENT

Be it Resolved by the People of the State of Ohio that Article I of the Ohio Constitution is amended to add the following Section:

> AKA: UNREGULATED ABORTION

Article I, Section 22. The Right to Reproductive Freedom with Protections for Health and Safety

A. Every individual has a right to make and carry out one's own reproductive decisions, including but not limited to decisions on:

- 1. contraception;
- 2. fertility treatment;
- continuing one's own pregnancy;
- 4. miscarriage care; and
- 5 abortion.

B. The State shall not, directly or indirectly, burden, penalize, prohibit, interfere with, or discriminate against either:

1. An individual's voluntary exercise of this right or

COERCION Anyone who coerces a girl into abortion would be protected by law

- 2. A person or entity that assists an individual exercising this right, unless the State demonstrates that it is using the least restrictive means to advance the individual's health in accordance with widely accepted and evidence-based standards of care.
- 3. However, abortion may be prohibited after fetal viability. But in no case may such an abortion be prohibited if in the professional judgment of the pregnant patient's treating physician it is necessary to protect the pregnant patient's life or health

The abortionist can be that physician!

C. As used in this Section:

by precedent, this is not just physical health, but also emotional, financial, & much more

- 1. "Fetal viability" means "the point in a pregnancy when, in the professional judgment of the pregnant patient's treating physician, the fetus has a significant likelihood of survival outside the uterus with reasonable measures. This is determined on a case-bycase basis."
- 2. "State" includes any governmental entity and any political subdivision.
- D. This Section is self-executing.

Thus: if you sign, babies could be killed LEGALLY during ALL 9 MONTHS of pregnancy.

Legal term. Laws restricting abortion are considered "burdens" by activist judges.
